Initial

- _____ This puppy is being purchased on _____ by above-named Buyer. To the best of the Breeder's knowledge and belief, this puppy is in good sound health. Upon exam by Breeder's veterinarian, this puppy is free from symptoms of contagious and infectious diseases and does not have any congenital/life-threatening conditions.
- _____ Puppy is to be checked by a veterinarian no later than 72 business hours from time of purchase or by end of business day (5:00 pm) on _____. If the puppy is not checked by a veterinarian of Buyer's choice there will be no health guarantee. After the above date, Buyer assumes all responsibilities for the puppy and there are NO REFUNDS for any reasons. If, in the opinion of examining veterinarian, the puppy is found to have a congenital disorder, the Buyer must notify Breeder within 24 hours of exam and Buyer has the choice of:
1) returning puppy for replacement puppy of equal value no later than two days from date of the exam with a written statement (including phone number) signed by Veterinarian stating condition. No exam costs or vet bills are the Breeder's responsibility and will not be reimbursed.
2) elect to keep puppy and assume any and all expenses related to puppy's care. All veterinarian costs are to be paid by the Buyer.
- _____ Breeder also extends the guarantee regarding congenital /life-threatening conditions to no longer than 1 year from date of birth. This guarantee does not cover what in this breed is considered normal, which includes cherry eye, stenotic nares, under bite, and both inguinal and umbilical hernias.
- _____ Replacement Guarantee will be terminated if puppy was abused, neglected, or does not have up to date records of vaccinations and fecal records. This includes issues of appropriate feeding, maintaining body temperature, exposure to harmful substances both biological and chemical, improper handling by children or other careless persons, attack by larger or aggressive animals, and exposure to unvaccinated canines including those possibly in contact at buyer's veterinarians office, pet supply stores, outdoor sites, or in owner's neighborhood.
- _____ This puppy is current on shots, worming, and other preventative treatments. A record of vaccinations and dates administered is attached to this contract. This is to be taken to buyer's veterinarian at time of initial visit so that treatment previously given will not be duplicated.
- _____ Buyer understands that this puppy is sold as "pet quality," ability to be shown or bred is not guaranteed. Color and size at maturity are not guaranteed. Puppy registration application has been given to the buyer today or will be mailed to above-named buyer at the address given above unless otherwise stated.
- _____ Buyer agrees to provide annual preventative care including physical examination, heartworm prevention, DHLPP and Rabies vaccinations. Buyer is aware that this is an indoor breed and is not to be kept outdoors. Buyer is also aware that due to the nature of this breed, it requires special grooming to maintain good health and general appearance of his/her coat.
- _____ Buyer agrees to maintain ownership of above-named dog. In the event Buyer is unable to keep dog, prior to transferring or relinquishing ownership, Buyer must notify Breeder. Breeder reserves the right to take back above-named dog and assume full financial responsibility. THIS DOG IS NEVER TO BE AT A SHELTER!
- _____ This contract is made and signed by both the Breeder and Buyer for the well being of the puppy and constitutes the complete agreement between both parties. No other guarantees or warranties are expressed or implied.
